## 4.) Principal's report -

<u>Staffing</u> – we are working through the challenges of chronic shortages. Most classes are experiencing minimal impact but we continue to work towards stable and purposeful situations in classes with teachers who are absent. The staff has been amazing in their support and flexibility during the time.

-The district continues to advertise for FrImm teachers both for replacements now and for upcoming positions next year. Unfortunately this is a provincial if not national, shortage for teachers and FrImm teachers in particular.
