## New Business

1. Discussion on jerseys for school events (Discussion points: Reversible, Quantity, Logo, etc.) Monique will be looking into how many and what kind of jerseys the school is looking for
a. MOTION: To purchase school jerseys for the students to attend events
i. Pending at the moment
2. Notice of election of executive members at June 14th Annual General Meeting
3. Notice of change to bylaws: Bylaws will be voted on June 14th
A) Deletion of all references to examples of committees such as "Hot Lunch" found on page 3, page 6 and page 11 of the LDB PAC Constitution and Bylaws.

The reason for this deletion is that we have many volunteers that informally volunteer and would not be able to attend committee meetings. Removing examples of who should form a committee allows PAC to be flexible on when to create a committee. The volunteer lists are more flexible and does not require appointment as a committee would require.
B) Changes to Executive Meetings on page 8 of the current bylaw to reduce the amount of executives needed to initiate a meeting. Executive meetings are a space for ideas and discussions on PAC matters. All financial decisions still must be approved at general PAC meetings. The current bylaw reads:

Executive meetings will be held at the call of the president or vice-president, should the president be unavailable. At least one meeting will be held before each general meeting. Quorum

The proposed amendment would read:
A quorum for executive meetings will be a majority ( $50 \%$ plus 1) of the members of the executive.

The reason for this change is that it may be difficult to get 4 executive members at an executive meeting before each general meeting. Since financial matters are voted on at general meetings, the current quorum requirements for executive meetings can at times be a challenge for the volunteer executive to meet and not violate the bylaw.
C) Changes to the current bylaw reads on Page 7 that reads:

Except as provided elsewhere in these bylaws, all matters requiring a vote will be decided by a simple majority of the votes cast ( $50 \%$ plus 1).

The amended bylaw would read:
Except as provided elsewhere in these bylaws, all matters requiring a vote will be decided by a simple majority of the votes cast ( $50 \%$ plus 1). At least 1 voting member must not be part of the executive.

The reason for this addition was that it was common practice among previous PAC execs to ensure this condition was met but was not written into the bylaws.
